DESTINATION IRELAND

Whether you are returning to Ireland or going there for the first time, there will inevitably be questions that you would like answered prior to your move.

The following guide will hopefully provide you with the information you need for importing motor vehicles, household goods and personal effects.

You should note that additional charges may be incurred if you import prohibited or restricted items. These charges along with taxes and duties, storage, demurrage, customs inspection, delivery that can only be serviced by ferry or delivery above 2nd floor without a lift are not included in our quotation.

CUSTOMS INFORMATION FOR THE IMPORT OF HOUSEHOLD GOODS AND MOTOR VEHICLES TO IRELAND

If you are changing residence from outside the EU to Ireland, you can bring in your used household goods, personal effects and auto, free of Irish Tax and Duty. However, you must comply with the following conditions:

- 1) Proof that you have resided outside Ireland for the past 12 months or more. Proof can be in the form of utility bills, bank statements, mortgage statements, lease agreements, etc. One document has to be at least one year old and the other must be current.
- 2) Complete a "Transfer of Residence" 1076 Custom Form. Form C&E 1076 can be obtained on the following web page <http://www.revenue.ie/pdf/1076rev1.pdf>
- 3) Copy of all the pages of your passport.
- 4) Proof you are taking up residence in Ireland. Proof can be in the form of a mortgage statement, new utility bill, a letter from your solicitor stating that they know who you are and that you are taking up residence at an Irish address, a job offer would be sufficient proof.
- 5) For your auto, show you have had the auto titled in your own name for at least six months.
- 6) Registration for the auto in your own name.
- 7) Bill of sale from when you purchased the auto.

MOTOR TRANSPORT INTO IRELAND:

If you would like to ship your motor vehicle to Ireland, it can be transported on its own or in a container with your household goods.

It can be shipped to Cork or Dublin port in Ireland and we will arrange for it to be custom cleared. Once custom cleared the container containing your motor vehicle will be hauled to our nearest warehouse and you would have to pick the vehicle up there. Your household goods would be unloaded from the back of the container at our warehouse and delivered by truck to your residence anywhere in Ireland.

Please note that you need clear **Title** to ship the auto. If there are any liens on the Title, we need the lien release paperwork to accompany the Title.

PROHIBITED OR RESTRICTED GOODS

Certain goods may not be imported/brought into the State or may only be imported/brought into the State under license.

These items include

- Firearms,
- Ammunition,
- Explosives,
- Dangerous drugs
- Indecent or obscene literature.

A full of list of prohibited or restricted goods is contained in the Customs and excise Tariff of Ireland
